

## Privacy Policy of the All NEMO Committee website

In order to participate in the ALL NEMO COMMITTEE public consultations or to subscribe to stay up to date, you may provide the ALL NEMO COMMITTEE with the following personal data: name, email address and company.

These personal data shall be processed by the ALL NEMO COMMITTEE, established by the All NEMO Cooperation Agreement which entered into force on 28 March 2019 pursuant to the Market Coupling Operator plan approved by all National Regulatory Authorities on 20 June 2017 pursuant to Article 7 of Commission Regulation (EU) 2015/1222 of 24 July 2015 establishing a guideline on capacity allocation and congestion management, acting as data controller and in compliance with the General Data Protection Regulation (GDPR) and any applicable implementation rules on the protection of privacy in relation to the processing of personal data, for the following purposes:

## 1. Public consultations

- Creation and publication of a list of consultation participants
- Creation and publication of documents relating to the subject of the consultation process
- Contacting you only for the purpose of the relevant public consultation

## 2. Subscriptions

- Creation of a data base to send the relevant updates
- Updates submission

By providing ALL NEMO COMMITTEE with your personal data, you give ALL NEMO COMMITTEE your express agreement to use the transmitted personal data for the above-mentioned purposes. The personal data transmitted to ALL NEMO COMMITTEE are registered in a database held by and under the responsibility of ALL NEMO COMMITTEE. These data will be used exclusively for the above-mentioned purposes, save express later disagreement from you. These data shall not be transmitted to any third party other than ALL NEMO COMMITTEE members, which shall process the transmitted personal data solely for the above-mentioned purposes.

The collection and processing of your personal data is based

- On your consent. If you no longer wish ALL NEMO COMMITTEE to further process your personal data for these purposes, you have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.
- On the performance by ALL NEMO COMMITTEE of its legally mandated tasks.

Your data shall be processed for a term of five years.

Your personal data shall not be transmitted to any third party, except

• ALL NEMO COMMITTEE service providers,





- ALL NEMO COMMITTEE Members,
- National Regulatory Authorities and ACER (Agency for the Cooperation of Energy Regulators).

Your data are stored exclusively on servers located within European Union.

Upon request dated and signed sent by email to ALL NEMO COMMITTEE (<a href="mailto:secretariat@nemo-committee.eu">secretariat@nemo-committee.eu</a>), and the proof of your identity, you may obtain, free of charge if it is a reasonable volume, the written communication of the data and the portability of the data, as well as, where appropriate, rectification, restriction of processing, deletion of those which are inaccurate, incomplete or irrelevant.
