DECISIONS

NEMO GOVERNANCE

- Fourth Amendment of All NEMO Cooperation Agreement (ANCA) entered into force in September 2025, which formally simplified the NEMO cooperation structure and NEMO Committee now serves as escalation body also to operational topics.
- NEMO Committee agreed on Terms of References (ToRs) for working groups, which have clarified the tasks and objectives of individual task forces, with aim to make the NEMO cooperation more efficient.
- ACER has open call for volunteers to be part of the European Stakeholder Group (ESG) on Demand Response. NEMO Committee provided their expert Fabrizio Carboni (GME).

REVISED CACM

- NEMOs were approached by their Member States representatives to provide feedback to EC's draft of revised CACM. NEMO Committee and its Governance Task Force supported individual NEMOs in preparing the positions.
- NEMO Committee triggered an internal process to prepare a common NEMO position for the hearing phase of the revised CACM.

JOINT GOVERNANCE

 The NEMO vote on the proposed decisions within the agenda of the MCSC meetings was pre-aligned by the All NEMO Committee, which ensured the efficiency of the MCSC meetings.

METHODOLOGIES

• NEMOs have formally submitted the HMMCP methodologies to ACER for decision.

SIGNIFICANT UPDATES IN DA OPERATION

- NEMOs and TSOs have finalised the implementation of the 15-min. MTU in SDAC across all European bidding zones and bidding zone borders on trading day 30th September 2025 for delivery day 1st October 2025.
- NEMOs are closely monitoring the stability of the system and have approved a set of mitigation and Corrective Measures in case the performance of the system would degrade.

CONTRACTUAL NEGOTIATION FOR EUPHEMIA ALGORITHM SUPPORT

• Main focus of the NEMO Committee was on contractual negotiation with the service provider, that supports the operation and development of Euphemia. NEMOs have agreed prolongation of the contract, which ensures stability of the operation of the DA system.

SIGNIFICANT UPDATES IN ID OPERATION

- Bursa Română de Mărfuri (BRM) has been successfully integrated into Single Intraday Auction 2nd Go-Live Wave.
- NEMOs and TSOs have agreed on a set of Corrective Measures, that may be implemented in case the
 performance of the SIDC system degrades. In parallel, NEMOs and the Service Provider are also discussing
 performance improvements and system boundaries, to make sure that the system will manage the everincreasing number of Order Transactions in the long term.

EXTERNAL COMMUNICATION

- NEMO Committee held 3rd Annual Conference on 24th September in Brussels, with a broad spectrum of representatives and panellists, such as Mr. Nicolás González Casares, Member of European Parliament and Mr. Lukasz Kolinski, Director for Green Transition and Energy System Integration at the Directorate-General for Energy of the European Commission.
- NEMO Committee was represented in the MESC meeting (3rd July) as well as CACM PCG meeting (23rd September).
