# DECISIONS

## NEMO GOVERNANCE

- The priority point for the Q1 2023 was European Commission's proposal for Electricity Market Design (EMD). NEMOs prepared a reply to the consultation as well as were active in subsequent discussions in the dedicated meeting. NEMOs also co-signed the Joint Industry Statement on the European Union's electricity market design where several associations make recommendations to be taken into account by the European Commission.
- NEMO Committee continues with the direct communication with the European Commission representatives and with Energy community about the clarification of the acquis communautaire that Power Exchanges from the Energy Community have to implement before formally becoming NEMOs and members of the All NEMO Committee.
- NEMOs have triggered a discussion on NEMOs vision for the future and also on the future closer cooperation with TSOs.

## JOINT GOVERNANCE

- The NEMO vote on the proposed decisions within the agenda of the MCSC meetings was pre-aligned by the All NEMOs Committee, which ensured the efficiency of the MCSC meetings.
- NEMOs and TSOs have triggered a discussion on projects prioritisation with future requirements and developments for SADC, SIDC and Pan-EU Intraday Auctions. They presented to the PCG of March 2023 the first project prioritisation which was welcomed by NRAs and ACER. This will be further discussed with ACER and NRAs in Q2 2023, as NEMOs and TSOs propose that the prioritisation principles shall be jointly agreed by all relevant stakeholders.

## COST SHARING KEYS FOR 2023

- NEMO Committee triggered the work on clarification of the NEMOs cost sharing keys for 2023. The CSKs are expected to be approved in April/May.

## SDAC PRODUCT METHODOLOGIES

- Based on the Art. 12 of CACM, NEMOs performed a regular review SDAC product methodology and proposed not to update it for the time being. This proposal was consulted with the Stakeholders and Market Participants, who confirmed NEMOs view. All results were published on the NEMO Committee website.

## CACM ANNUAL REPORT

- NEMOs have triggered the work on CACM Annual report and also planning of the NEMO annual conference, where the report will be presented. The report will be published by 30th June.

## CO-OPTIMISATION

- NEMOs have published a Co-optimisation Study roadmap, that aims to provide additional context & background to the results of the study. NEMO Committee decided to put on hold the R&D work on non-uniform pricing because performance gains are not very promising and implementation challenges are very cumbersome.
